- 1. Learned counsel for the parties have tendered Consent Terms dated 20 April 2017 duly signed by the authorized representatives of the parties and their respective Advocates. The signatures of the parties are identified by the Advocates for the parties.
- 2. Learned counsel for the Petitioner has annexed a copy of the Special Power of Attorney whereas learned Counsel for the Respondent has annexed a copy of the Board Resolution passed by the Respondent. The Consent Terms are taken on record and marked 'X' for identification. Undertakings recorded in the consent terms are accepted.

- 3. Learned counsel for the Respondent states that a sum of Rs.25,000/- would be paid to the Official Liquidator which amount can be used by the Official Liquidator towards office expenses. The Respondent has agreed to pay such charges within a period of one week from today without fail. Statement is accepted.
- 4. Company Petition is disposed of in terms of consent terms.
- 5. Official Liquidator is discharged.
- 6. However, the payment of Rs.25,000/- shall be paid within a period of one week from today. Learned counsel for the Respondent has handed over a Demand Draft dated 2 March 2017 for a sum of US D 6,80,000 to the learned Counsel appearing for the Petitioner in Court.
