'Kushner gets permanent security clearance'

JARED KUSHNER, THE sonin-law of US President Donald Trump, has finally received security clearance, a media report said on Thursday, bringing cheers to his supporters and the White House staffers.

The permanent security clearance for Kushner had been pending since last year.

"Having completed all of these processes, he's looking forward to continuing to do the work the president has asked him to do," said Abbe D Lowell, attorney of Kushner, in a statement.

He said Kushner's application was "properly" submitted, reviewed by numerous career officials and underwent the normal process.

According to The New York Times, Kushner was issued permanent security clearance by career staffers of the FBI, after the investigative agency completed its background check against the president's son-in-law.
