To, The Board of Directors, Shree Precoated Steels Limited Mumbai.

We have reviewed the accompanying Statement of Unaudited Standalone Financial Results of SHREE PRECOATED STEELS LIMITED ("the Company"), for the quarter and nine months ended December 31, 2019 ("the Statement").
